- 3) After the trip has filled up, vacancies (if any) will be filled from the waiting list in order of sign-up.
- 4) You agree and comply with the payment schedule presented for the trip.
- 5) You are responsible for any connections up to and including getting to the lodging on your own. The Club is not responsible for any additional expenses incurred, time lost or unused lodging or events.
- 6) It is your responsibility to arrange for payment for your own lodging and to have proper travel identification and payment for lodging upon arrival (such as driver's license and credit card). The Club is not responsible for lost time, additional expenses incurred or total loss of a trip because your payment for lodging is denied.

#### **CANCELLATION POLICY**

- 1) Any cancellation must be made in writing to the Trip Leader. You are still considered on the trip until the Trip Leader receives your written cancellation.
- 2) The cancellation fee is a minimum \$25 unless you are transferring to another Gator trip, not previously signed up for. However, the Club will also hold you accountable for any money paid to outside vendors on your behalf not refunded to the Club. The minimum cancellation fee can only be waived by the Board of Directors of the Gator Snow Ski Club.
